CURIAM. 1 Samsak Patarajanakarn appeals the 235-month sentence imposed by the district court¹ after he pleaded guilty to conspiring to distribute methamphetamine, in violation of 21 U.S.C. § 846.

We affirm. 2 At his sentencing hearing, Patarajanakarn testified that he had not possessed or distributed methamphetamine during the period of the conspiracy. After the government began a direct examination of the probation officer who prepared Patarajanakarn's presentence report (PSR),

Patarajanakarn testified that he had explained the substance of his testimony to the probation officer. He then indicated that the probation officer had not included this information in the PSR. The government then moved to strike Patarajanakarn's testimony, and the district court decided to allow Patarajanakarn to read to the jury his previous testimony from the sentencing hearing. 3 On appeal,

Patarajanakarn argues that the district court abused its discretion when it allowed him to give a "revised" statement for the record, because the government was not timely given notice of the new testimony. 4 We disagree. The record shows that the government was given notice of the additional testimony well in advance of the sentencing hearing, and that it moved for the court to strike the testimony.
